- 5. Recognition and Enforcement of Canadian Domestic Violence Protection Orders
- 6. Parentage Act

JP – Chairing Parentage, also on Non-Parental Child Custody and Visitation
MR – Anti-SLAPP study committee
MA – Open Meetings and Public Records informal committee
DC – Is one of eight parliamentarians who will serve during the annual meeting and is awaiting assignment
